#### **Intellectual Property Assignment**

- C. In consideration of the payment of the purchase price under the Asset Purchase Agreement to Assignor, which Assignor acknowledges and agrees is a benefit to Assignor, and in furtherance of the performance of Assignor's obligations under the Asset Purchase Agreement, Assignor has agreed to execute and deliver this Assignment in order to assign and transfer the Intellectual Property Rights owned by Assignor to Assignee.

- 1. <u>Incorporation of Recitals</u>. The foregoing recitals are incorporated into and made a part of this Assignment as if fully set forth herein.
- 2. <u>Assignment.</u> Subject to the terms and conditions set forth herein, Assignor hereby irrevocably sells, assigns, transfers, conveys and delivers to Assignee, and Assignee hereby accepts, all right, title, and interest of Assignor in and to the Intellectual Property Rights (and, in the case of Intellectual Property Rights licensed but not owned by the Assignor, all right, title, and interest in the license rights corresponding to such Intellectual Property Rights, only to the extent such license rights are freely transferrable), free and clear of all Liens and Orders, including:
- (a) the Intellectual Property Rights listed on <u>Schedule 1</u>, together with the goodwill connected with the use of, and symbolized thereby;
- (b) all contractual licenses and similar contractual rights or permissions that are included in the Intellectual Property Rights, whether exclusive or nonexclusive, related to any of the foregoing, to the extent freely transferable;
- (c) all Intellectual Property Rights contained in or associated with the Purchased Assets;
- (d) all royalties, fees, income, payments, and other proceeds now or hereafter due or payable to Assignor with respect to any of the foregoing;
- (e) all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, violation, breach, or default; and
- (f) all other rights, privileges, and protections of any kind whatsoever of Assignor accruing under any of the foregoing provided by any applicable law, treaty, or other international convention throughout the world.
- 3. <u>Further Actions</u>. Following the date hereof, upon Assignee's reasonable request, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its

successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be necessary to effect, evidence, or perfect the assignment of the Intellectual Property Rights to Assignee, or any assignee or successor thereto.

- 4. Terms of the Asset Purchase Agreement. The parties hereto acknowledge and agree that this Assignment is entered into pursuant to the Asset Purchase Agreement, to which reference is made for a further statement of the rights and obligations of Assignor and Assignee with respect to the assigned Intellectual Property Rights. The representations, warranties, covenants, agreements, and indemnities contained in the Asset Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Asset Purchase Agreement and the terms hereof, the terms of the Asset Purchase Agreement shall govern.
- 5. <u>Governing Law.</u> This Assignment and any claim, controversy, dispute, or cause of action (whether in contract, tort, or otherwise) based upon, arising out of, or relating to this Assignment and the and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Delaware, without giving effect to any choice or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction).
- 6. <u>Counterparts</u>. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.


