**PARTIAL RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This **PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**, dated as of April 26, 2024 (this “**Release**”), is made by **ANTARES CAPITAL LP**, as administrative agent (the “**Agent**”), in favor of **RANDALL-REILLY, LLC**, a Delaware limited liability company (the “**Grantor**”).

WHEREAS, the Grantor entered into that certain Credit Agreement, dated as of February 19, 2021 (as the same may be amended, restated, supplemented and/or otherwise modified from time to time, the “**Credit Agreement**”), that certain Guaranty and Security Agreement, dated as of February 19, 2021 (as the same may be amended, restated, supplemented and/or otherwise modified from time to time “**Guaranty and Security Agreement**”), and that certain Trademark Security Agreement, dated as of February 19, 2021 (the “**Trademark Security Agreement**”), which Trademark Security Agreement was recorded on February 22, 2021 in the United States Patent and Trademark Office at Reel 7199, Frame 0697 pursuant to which the Grantor granted to the Agent a security interest in and lien on all right, title and interest of the Grantor in certain Trademark Collateral (as defined in the Trademark Security Agreements), including the Trademark listed on Schedule A attached hereto (the “**Released Trademarks**”).

NOW THEREFORE, in consideration of the material covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby RELEASES, terminates, cancels and discharges, without representation, recourse or warranty whatsoever, in its entirety its security interest in and to the Released Trademarks. The Agent hereby reassigns, re-transfers and re-conveys to the Grantor and its successors and assigns any and all of its right, title and interest in and to the Released Trademarks, together with (a) all renewals and extensions of the Released Trademarks, (b) all goodwill of the business connected with the use of, and symbolized by, the Released Trademarks, (c) all rights to sue or recover at law or in equity for any past, present or future infringement, dilution, violation or other impairment of any of the Released Trademarks and (d) all income, royalties, proceeds, Liabilities and other payments at any time due or payable or asserted under and with respect to any of the Released Trademarks. For the avoidance of doubt, except as expressly set forth above, nothing herein shall affect the security interest and lien held by the Agent in any other Trademark Collateral or any other security interest granted by the Grantor or any other grantors to the Agent.


The Agent hereby authorizes this Release to be filed and recorded with the United States Patent and Trademark Office and any other offices as may be necessary to carry out the intention of this Release.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
