TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of May 1, 2024 (“Release”), is made by Bank of Montreal, a Canadian chartered bank (“Bank”) in favor of Engineered Plastics, Inc., a New York corporation (“Pledgor”).

WHEREAS, pursuant to a Credit Agreement as of April 26, 2018 as amended by a first amendment dated as of August 31, 2018, a second amendment dated as of December 4, 2018, a third amendment dated as of February 28, 2019, a fourth amendment dated as of September 12, 2019, a fifth amendment dated as of May 29, 2020 and a sixth amendment dated as of February 7, 2022 (collectively, “Security Agreement”) by and among the Pledgor, Bank, and others party thereto and a Trademark Collateral Agreement dated as of April 26, 2018 (“Trademark Security Agreement”) by and among the Pledgor and Bank, Pledgor granted to the Bank a security interest in all its rights, title and interest in and to all Collateral (as defined in the Trademark Security Agreement); and

WHEREAS, pursuant to the Trademark Security Agreement, Pledgor executed and delivered to Bank Notices of Security Interest recorded at the United States Patent and Trademark Office (“USPTO”) on April 30, 2018 at Reel 6323 Frame 0424 and on May 15, 2018 at Reel 6330 Frame 0596 (“Notices”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank and Pledgor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement, Trademark Security Agreement, or Notices.

SECTION 2. Termination and Release. Bank, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges, and releases the security interest in all its rights, title and interest in and to all Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement, Trademark Security Agreement, or Notices; and

(b) authorizes the recordation of this Release with the USPTO at Pledgor’s expense.


SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.
