TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this “*Termination and Release*”) is granted as of April 30, 2024 by MIDCAP BUSINESS CREDIT LLC (the “*Assignee*”), in favor of BARTON MINES CORPORATION, a Pennsylvania corporation (the “*Grantor*”).

WHEREAS, the Grantor executed and delivered that certain Intellectual Property Security Agreement, dated as of May 12, 2022 (the “*IP Agreement*”), pursuant to which the Grantor granted to the Assignee a security interest in and lien on certain (i) trademarks and trademark applications as described more fully therein (the “*Marks*”), which IP Agreement was recorded with the trademark division at the United States Patent and Trademark Office (“*USPTO*”) on May 12, 2022 at Reel 7720, Frame 0238 and (ii) patents and patent applications as described more fully therein (the “*Patents*” and together with the Marks, collectively, the “*IP Collateral*”), which IP Agreement was recorded with the patent division at the USPTO on May 12, 2022 at Reel 060023, Frame 0346;

WHEREAS, the Grantor has requested that the Assignee hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantor in, to and under all of the IP Collateral as herein provided; and


WHEREAS, the Grantor has requested that the Assignee provide a document suitable for recording with the USPTO to evidence the release of the Assignee’s security interests in and liens on the IP Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby:

1. terminates and cancels the IP Agreement and releases, terminates and discharges all liens and security interests in the Grantor’s right, title and interest in, to and under (i) the Marks, including without limitation those trademarks, service marks, trademark registrations, service mark registrations, trademark applications, and service mark applications identified in Schedule A hereto, (ii) the Patents and patent applications identified in Schedule B hereto, (iii) all proceeds of the IP Collateral, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the IP Collateral;
2. assigns, transfers and conveys to the Grantor any interest in all of the foregoing, including any lien and security interest thereof; and
3. authorizes and requests that this Termination and Release be recorded with the USPTO.

IN WITNESS WHEREOF, the Assignee has executed this Termination and Release by its duly authorized officer as of the date first above written.
