**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of May 2, 2024 (the “Effective Date”), is made by WILMINGTON TRUST, NATIONAL ASSOCIATION, as Collateral Agent for the Secured Parties (in such capacity, the “Agent”), in favor of TRAVELPERK, S.L.U., a company organized under the laws of Spain (in such capacity, “Grantor”). Capitalized terms used but not defined herein have the meanings ascribed thereto in the Trademark Security Agreement (as defined below) (whether defined therein or by reference to another agreement).

WHEREAS, pursuant to that certain U.S. Guarantee and Collateral Agreement by and among the Grantor, the other Subsidiary Guarantors (as defined therein) time to time party thereto, TravelPerk Inc., a Delaware corporation, and the Agent, dated as of July 2, 2021 (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”), the Grantor executed and delivered a Trademark Security Agreement, dated as of July 2, 2021 (the “Trademark Security Agreement”), which was recorded in the United States Patent and Trademark Office (“USPTO”) on July 2, 2021 at Reel/Frame 7344/0961.

WHEREAS, pursuant to the Collateral Agreement and the Trademark Security Agreement, the Grantor pledged and granted to the Agent, for the benefit of the Secured Parties, a security interest (the “Security Interest”) in all right, title and interest in or to any and all of the Grantor’s Trademarks then owned or at any time thereafter acquired by it or in which the Grantor then had or at any time in the future may acquire any right, title or interest (collectively, the “Trademark Collateral”).

WHEREAS, the Grantor has requested the Agent to release the Security Interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby, without recourse to or representation or warranty by the Agent of any kind, (i) terminates the Trademark Security Agreement, (ii) releases, discharges, terminates and cancels the Security Interest in the Trademark Collateral, and (iii) re-assigns to the Grantor any right, title or interest it may have in the Trademark Collateral of such Grantor.

The Grantor and any successor to the Grantor (including any person or entity hereafter holding any right, title or interest in or to the Trademark Collateral of the Grantor), is hereby authorized to record this Release in the USPTO.
