**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (“Release”) is made as of May 3, 2024, by PNC BANK, NATIONAL ASSOCIATION, a national banking association, as Agent for itself and certain lenders (in such capacity, together with its successors and assigns, if any, the “Grantee”), in favor of STORAGE SQUAD LLC, a Delaware limited liability company (the “Grantor”).

WHEREAS, pursuant to that certain Revolving Credit and Security Agreement, dated as of November 2, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), the Grantor entered into a certain Trademark Security Agreement, dated as of June 22, 2021, with the Grantee, notice of which was recorded with the United States Patent and Trademark Office (“USPTO”) on July 2, 2021, at reel/frame 007344/0990 (the “Trademark Security Agreement”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Grantor has granted to the Grantee for the benefit of the Secured Parties (as defined in the Credit Agreement) a continuing security interest in all right, title and interest of Grantor in, to and under the Trademarks (as defined herein), together with, among other things, the good-will of the business symbolized by the Trademarks the applications and registrations of each thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof, including, without limitation, the Trademarks listed in Schedule 1 (the “Trademarks”).


WHEREAS, the Grantee has agreed to terminate and release its security interest in all such Trademarks and terminate the Trademark Security Agreement as herein provided.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, the Grantee hereby (a) releases, terminates and discharges its security interest in the Trademarks, including the Trademarks listed on Schedule 1 attached hereto and made a part hereof, (b) terminates the Trademark Security Agreement and (c) assigns, transfers and conveys to the Grantor any right, title or interest, including the security interest, it may have in the Trademarks. The Grantor, or any successor(s) to the Grantor (including any person or entity hereafter having any right, title, or interest in or to the Trademarks), is hereby authorized to record this Release with the USPTO.
