EACH HOLDER OF ANY SECOND LIEN OBLIGATIONS (AS DEFINED IN THE A&R INTERCREDITOR AGREEMENT) (I) CONSENTS TO THE SUBORDINATION OF LIENS AS PROVIDED FOR IN THE A&R INTERCREDITOR AGREEMENT, (II) AGREES THAT IT WILL BE BOUND BY, AND WILL TAKE NO ACTIONS CONTRARY TO, THE PROVISIONS OF THE A&R INTERCREDITOR AGREEMENT AND (III) AUTHORIZES AND INSTRUCTS THE SECOND LIEN AGENTS ON BEHALF OF EACH SECOND LIEN SECURED PARTY (EACH TERM AS DEFINED THEREIN) TO ENTER INTO THE A&R INTERCREDITOR AGREEMENT AS SECOND LIEN AGENTS ON BEHALF OF THE APPLICABLE SECOND LIEN SECURED PARTIES. THE FOREGOING PROVISIONS ARE INTENDED AS AN INDUCEMENT TO THE LENDERS UNDER THE PRIORITY CREDIT AGREEMENT (AS DEFINED IN THE A&R INTERCREDITOR AGREEMENT) TO EXTEND CREDIT TO ONX AND SUCH LENDERS ARE INTENDED THIRD PARTY BENEFICIARIES OF SUCH PROVISIONS AND THE PROVISIONS OF THE A&R INTERCREDITOR AGREEMENT.




