**RELEASE OF SECURITY INTEREST

WHEREAS, the Grantors have requested that Agent release its security interest in and to all other intellectual property assets set forth in Sections (a) through (j) of the IP Security Agreement (together with the Released Patents and Released Trademarks, collectively, the “**Released IP Collateral**”).

NOW, THEREFORE, Agent, without recourse, representation or warranty and at the Grantors’ sole cost and expense, hereby releases all of Agent’s right, title and interest in and to the Released IP Collateral, including the issued patents, patent applications, trademark registrations, and trademark applications set forth in Schedules A and B attached hereto and incorporated herein by reference, and agrees that all the security interest in the Released IP Collateral is hereby discharged, terminated and released.


