RESOLVED, FURTHER, that said amendment shall be effective as of the 28th day of June, 2021.

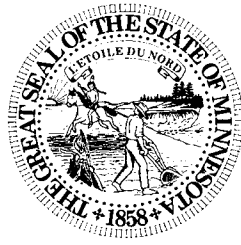
