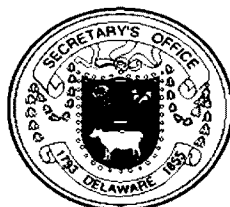

CERTIFICATE OF OWNERSHIP AND MERGER

MERGING

HERMAN'S SUPPLY COMPANY, INC.
(a Delaware corporation)
(the Subsidiary)

WITH AND INTO

AMERICAN BUILDERS & CONTRACTORS SUPPLY CO., INC.
(a Delaware corporation)
(the Corporation)

Pursuant to Section 253 of the Delaware General Corporation Law (the "DGCL"), American Builders & Contractors Supply Co., Inc., a Delaware corporation (the "Corporation"), does hereby certify to the following information relating to the merger (the "Merger") of Herman's Supply Company, Inc., a Delaware corporation (the "Subsidiary"), with and into the Corporation, with the Corporation remaining the surviving corporation:

FIRST: The Corporation was incorporated pursuant to the DGCL on May 1, 1997.

SECOND: The Corporation owns 100% of the capital stock of the Subsidiary, a corporation organized under the DGCL on February 18, 2016.

THIRD: The Board of Directors of the Corporation, by the following resolutions duly adopted by unanimous written consent on April 1, 2024, determined to merge the Subsidiary with and into the Corporation pursuant to Section 253 of the DGCL:

WHEREAS, upon closing of the transactions approved above, the Corporation will be the sole holder of all of the issued and outstanding shares of capital stock of Herman's Supply Company, Inc., a Delaware corporation (the "Subsidiary"); and

WHEREAS, it is deemed advisable and in the best interest of the Corporation that the Corporation merge the Subsidiary with and into the Corporation.

NOW, THEREFORE, BE IT RESOLVED, that the Subsidiary be merged with and into the Corporation pursuant to Section 253 of the Delaware General Corporation Law (the "Merger"), so that the separate existence of the Subsidiary will cease as soon as the Merger will become effective, and the Corporation will continue as the surviving corporation.

FURTHER RESOLVED, that the President, any Vice President, Treasurer, Secretary, Assistant Secretary, and any other officer of the Corporation (each such person, an "Authorized Officer") be, and each of them hereby is, authorized to prepare and execute a Certificate of Ownership and Merger setting forth a copy of these resolutions, and to file the Certificate of Ownership and Merger with the Secretary of State of Delaware and pay any fees related to such filing.

FURTHER RESOLVED, that the Authorized Officers be, and each hereby is, authorized and directed to take all further actions, whether within or without the State of Delaware that may be in any way necessary or proper to effect the Merger.


FOURTH: The Corporation will be the surviving corporation of the Merger.

FIFTH: The certificate of incorporation of the Corporation as in effect immediately prior to the effective time of the Merger will be the certificate of incorporation of the Corporation, as the surviving corporation of the Merger.

SIXTH: This Certificate of Ownership and Merger will become effective on the date this Certificate is filed with the office of the Secretary of State.
