**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of April 26, 2024 (“Effective Date”) by FORTRESS CREDIT CORP., a Delaware corporation, as collateral agent acting for the benefit of the Secured Parties (“Collateral Agent”), in favor of Aspire Channel, LLC, a Delaware limited liability company (the “Grantor”).

**WHEREAS**, Collateral Agent, Grantor and the other grantors party thereto have entered into that certain Security and Pledge Agreement, dated as of October 9, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time prior to the date hereof, the “Security Agreement”);

**WHEREAS**, pursuant that certain Grant of Security Interest in Trademark Rights dated as of October 9, 2019 and recorded with the United States Patent and Trademark Office (“USPTO”) on October 9, 2019, at Reel Frame 6767/0291 (the “Trademark Security Agreement”), Grantor granted to the Collateral Agent, for the benefit of the Secured Parties, a continuing security interest in and to all of Grantor’s right, title and interest in and to all of the trademarks, and registrations of and applications to register the foregoing and all of the trade names and assumed names owned by Grantor (collectively, the “Trademarks”), including, without limitation, the Trademark Collateral as set forth on Schedule A attached hereto, in each case, together with the goodwill associated therewith; and

**WHEREAS**, Collateral Agent has agreed to terminate the Trademark Security Agreement and terminate and release the entirety of its lien on and security interest in and to all Trademark Collateral, including those Trademarks set forth on Schedule A attached hereto and to reconvey any and all of its rights, title and interests in, to and under the Trademark Collateral to the Grantors.

**NOW, THEREFORE**, in consideration of the promises and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. **Defined Terms**. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.
2. **Release**. The Collateral Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate, release and discharge any lien on and security interest in all the Trademark Collateral, including, for the avoidance of doubt, those Trademarks set forth on Schedule A attached hereto and any other right, title or interest granted to the Collateral Agent in any Trademarks of the Grantor (or any other signatory to the Security Agreement as a grantor), and (b) discharge and reassign to the Grantor any and all rights, title and interest they have (if any) in the Trademark Collateral. The parties hereto authorize and request the USPTO to record this Release against the Trademarks set forth on Schedule A attached hereto.
3. **Further Assurances**. The Collateral Agent agrees to deliver to the Grantor, at the expense of the Grantor, such other writings or records as the Grantor shall reasonably deem necessary to effectuate or better evidence the agreements and assignment contained in this Release.
