RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the “Release”) is made as of November 1, 2021, by ALLY BANK, as agent (in such capacity, together with its successors and permitted assigns in such capacity, “Agent”) for the Lenders (as defined in the applicable Security Agreement defined below). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the applicable Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, Critical Nurse Staffing, LLC (“Grantor”) and Agent are parties to that certain Trademark Security Agreement dated as of March 29, 2018 (as amended, restated, supplemented or otherwise modified, the “First Security Agreement”) pursuant to which Grantor granted to Agent a lien on and security interest in, to and under the Trademark Collateral (as defined in the First Security Agreement) as security for certain obligations owing by Grantor to Agent;

WHEREAS, Grantor and Agent are parties to that certain Trademark Security Agreement dated as of February 21, 2020 (as amended, restated, supplemented or otherwise modified, the “Second Security Agreement”) and, collectively with the First Security Agreement, the “Security Agreements”) pursuant to which Grantor granted to Agent a lien on and security interest in, to and under the Trademark Collateral (as defined in the Second Security Agreement) as security for certain obligations owing by Grantor to Agent;

WHEREAS, the First Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on March 29, 2018, at Reel 6303, Frame 0579;

WHEREAS, the Second Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on February 21, 2020, at Reel 6869, Frame 0296; and

WHEREAS, Grantor has requested that Agent release its lien in the Trademarks and all Trademark Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its lien on and security interest in, to and under all of Grantor’s respective right, title and interest in and to the Trademark Collateral (as defined in each Security Agreement), which includes but is not limited to the following:

- (a) all of its Trademarks, including those referred to on Schedule 1 hereto;
- (b) all of the goodwill of the business connected with the use of, and symbolized by, each such Trademark;
- (c) all renewals and extensions of the foregoing; and
- (d) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, any and all of Agent's right, title and interest in, to and under the Trademark Collateral. Agent hereby authorizes Grantor (or their designee) to file this Release with the United States Patent and Trademark Office.
