TERMINATION AND RELEASE OF  
SECOND LIEN SECURITY INTEREST IN TRADEMARKS

This Termination and Release of Second Lien Security Interest in Trademarks (this “Release”) is made as of May 6, 2024, by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH (in such capacity, together with its successors and assigns, the “Collateral Agent”) in favor of ADVA HOLDINGS, LLC, a Delaware limited liability company with an address at 1277 Treat Boulevard, Suite 800, Walnut Creek, California 94597, PARADIGM MANAGEMENT SERVICES, LLC, a Delaware limited liability company with an address at 1277 Treat Boulevard, Suite 800, Walnut Creek, California 94597, FORESIGHT MEDICAL, LLC, an Indiana limited liability company with an address at Two Urban Centre, 4890 West Kennedy Boulevard, Suite 650 Tampa, Florida 33609 and THE ALARIS GROUP, INC., a Minnesota corporation with an address at 1277 Treat Boulevard, Suite 800, Walnut Creek, California 94597 (each, a “Grantor” and collectively, the “Grantors”).

WITNESSETH:

WHEREAS, each Grantor entered into a certain second lien trademark security agreement dated October 26, 2018 (the “Trademark Security Agreement”) with the Collateral Agent, notice of which was recorded on October 26, 2018 at the United States Patent and Trademark Office at Reel 6468, Frame 0891.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, each Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in all of each such Grantor’s right, title and interest in and to the Trademark Collateral, including without limitation the Owned Trademarks listed on Schedule A, and all proceeds of, and all causes of action arising prior to or after the date thereof for infringement of or unfair competition with respect to, any of the Trademark Collateral and all goodwill associated with such Trademark Collateral.


WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders and the other holders of the Security Interest, hereby releases, terminates and discharges (in each case, without any recourse to, or any representation or warranty by, the Collateral Agent) any and all of its interest in the Trademark Collateral of the Grantors, including the goodwill associated with such Trademark Collateral, and assigns, transfers and conveys to the applicable Grantors (in each case, without any recourse to, or any representation or warranty by, the Collateral Agent) any security interest in such intellectual property, including the Security Interest.


