RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL, dated as of April 26, 2024 (this “Release”), is made by TRIPLEPOINT VENTURE GROWTH BDC CORP., a Maryland corporation in its capacity as collateral agent (in such capacity, together with its successors and assigns, the “Collateral Agent”) under the Loan Agreement (as defined below) in favor of PERSONAL RETAILING, INC., a Delaware corporation (the “Grantor”).

WITNESSETH

WHEREAS, inter alios, the Grantor and Collateral Agent are party to that certain Plain English Growth Capital Loan and Security Agreement, dated as of November 30, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Loan Agreement”);

WHEREAS, pursuant to the Loan Agreement, the Grantor executed that certain Plain English Intellectual Property Security Agreement, dated as of November 30, 2020 (the “IP Security Agreement”), recorded with the U.S. Patent and Trademark Office on December 23, 2020 at Reel/Frame No. 7143/0789, pursuant to which the Grantor granted and pledged to Collateral Agent a lien upon and continuing security interest in all of its right, title, and interest in, to and under the Intellectual Property Collateral (as defined in the IP Security Agreement); and

WHEREAS, the Grantor has requested that the Collateral Agent release its lien on and security interest in all right, title, and interest in, to and under the Intellectual Property Collateral.


NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby discharges, terminates and releases, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under the Intellectual Property Collateral, including the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Intellectual Property Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Intellectual Property Collateral under the Loan Agreement and the IP Security Agreement.
