**RELEASE OF PATENT, COPYRIGHT AND TRADEMARK SECURITY INTEREST**

This **RELEASE OF PATENT, COPYRIGHT AND TRADEMARK SECURITY INTEREST** (this “Release”) is made as of May 6, 2024, by **CENTERFIELD CAPITAL PARTNERS V, L.P.**, in its capacity as Administrative Agent (the “Agent”) for the benefit of **J & D HOME IMPROVEMENT, LLC**, d/b/a The Basement Doctor (formerly J & D Home Improvement, Inc.), an Ohio limited liability company, **CRAWL SPACE DIY LLC**, an Ohio limited liability company, **NASH DISTRIBUTION LLC**, an Ohio limited liability company, **J & D BASEMENT SYSTEMS NORTHWEST, LLC**, a Delaware limited liability company, **BDCS ACQUISITION CO.**, a Delaware corporation, **BSNW ACQUISITION CO.**, a Delaware corporation, and **DRY ACQUISITION CO., LLC**, a Delaware limited liability company (collectively, the Debtors ). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement (as defined below), or the IP Security Agreement (as defined below), or as applicable.

**WITNESSETH:**

WHEREAS, the Debtors and Agent are parties to that certain (i) Intellectual Property Security Agreement, dated as of July 27, 2022 (as the same may be amended, modified, extended or restated from time to time, the “Security Agreement”); and (ii) Notice of Grant of Security Interest in Patents, Copyrights and Trademarks, dated as of July 27, 2022 (as the same may be amended, modified, extended or restated from time to time, the “IP Security Agreement”), pursuant to which the Debtors have granted to the Agent for the benefit of the Secured Parties a lien on and security interest in all of the right, title and interest of the Debtors in, to and under the patents and patent applications, copyrights and copyright applications and trademarks and trademark applications listed on Schedule 1, Schedule 2, and Schedule 3 attached hereto;

WHEREAS, the IP Security Agreement was recorded in the United States Patent and Trademark Office (“USPTO”) on July 29, 2022 at Reel 7806 and Frame 0944; and

WHEREAS, the Debtors requested that the Agent release, and the Agent is willing to release its lien on and security interest in, and any other right, title, and interest it may have in, to and under the patents and patent applications, copyrights and copyright applications and trademarks and trademark applications listed on Schedule 1, Schedule 2, and Schedule 3.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. The Agent does hereby irrevocably terminate, release and discharge the entirety of any and all liens or security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the Security Agreement or IP Security Agreement to the patents and patent applications, copyrights and copyright applications and trademarks and trademark applications listed on Schedule 1, Schedule 2, and Schedule 3, the goodwill of the business symbolized by the trademarks and the applications and registrations thereof, and all

proceeds thereof, and any right, title or interest of the Agent in such patents and patent applications, copyrights and copyright applications and trademarks and trademark applications shall hereby terminate, cease and become void. The Agent hereby assigns, transfers and conveys any and all right, title or interest of the Agent in the patents and patent applications, copyrights and copyright applications and trademarks and trademark applications to the Debtors.

2. The Agent, on behalf of itself and the Secured Parties, does hereby terminate and cancel the IP Security Agreement.

3. The Agent hereby authorizes the Debtors or the Debtors' authorized representative to (i) record this Release with the USPTO, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of the Agent in the patents and patent applications, copyrights and copyright applications and trademarks and trademark applications and/or, (iii) otherwise record or file this Release in the applicable governmental office or agency. The Agent further agrees to execute and deliver to the Debtors any and all further documents and instruments prepared by the Debtors, and do any and all further acts which the Debtors (or its agents or designees) reasonably request (at the Debtors' sole cost and expense) in order to confirm this Release and the Debtors' right, title and interest in, to and under the patents and patent applications, copyrights and copyright applications and trademarks and trademark applications.

4. This Release may be executed in any number of counterparts (including electronic transmission and facsimile counterparts), each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.

5. This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York.


