RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this “Release”) is made as of May 7, 2024 by Crescent Capital BDC, Inc. (as successor by merger to Alcentra Capital Corporation), in its capacity as Collateral Agent and Administrative Agent (in such capacities, the “Collateral Agent”), in favor of Carlton Group Ltd., (“Grantor”). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Trademark Security Agreement (defined below), or if not defined therein, in the Security Agreement (defined below).

WHEREAS, Grantor is a party to that certain Trademark Security Agreement, dated as of September 29, 2017, in favor of the Collateral Agent (the “Trademark Security Agreement”), pursuant to which the Grantor granted to the Collateral Agent a security interest in all of Grantor’s right, title and interest in and to the Trademark Collateral;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 6167, Frame 0554 and at Reel 6167, Frame 0562 on October 2, 2017;

WHEREAS, Grantor has requested that the Collateral Agent terminate, release and discharge fully its security interest in all of Grantor’s right, title and interest in and to the Trademark Collateral, including each trademark and trademark application listed on the attached Schedule A hereto, and execute a document suitable for recording in the United States Patent and Trademark Office to evidence the release of its security interests in the Trademark Collateral as herein provided.


NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, without representation or warranty of any kind, hereby releases, relinquishes and discharges all of its security interest in and to all of the Grantors’ right, title, and interest in and to the Trademark Collateral, and re-assigns to Grantor any and all right, title or interest it may have in such Trademark Collateral.

The Collateral Agent hereby authorizes Grantor, or Grantor’s authorized representatives, to record this Release with the United States Patent and Trademark Office and/or any other applicable governmental office or agency. The Collateral Agent agrees to execute and deliver to Grantor other instruments and other documents as may be necessary to release the security interest in the Trademark Collateral which had been granted under the Trademark Security Agreement.

THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK WITHOUT REGARD TO CONFLICT OF LAWS PRINCIPLES THEREOF THAT WOULD RESULT IN THE APPLICATION OF ANY LAW OTHER THAN THE LAW OF THE STATE OF NEW YORK (OTHER THAN ANY MANDATORY PROVISIONS OF LAW RELATING TO THE LAW GOVERNING PERFECTION AND THE EFFECT OF PERFECTION OF THE SECURITY INTEREST).
