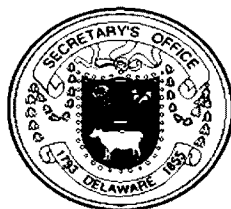


1. The name of the Company is Liberty Oilfield Services LLC.

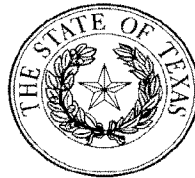

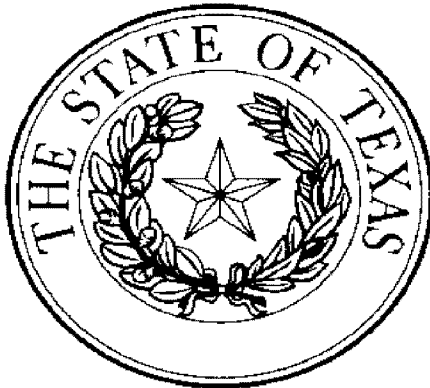

Pursuant to the provisions of Section 10.102 and Section 10.154 of the Texas Business Organizations Code, Liberty Oilfield Services LLC, a Delaware limited liability company (the "**Company**"), hereby executes the following Certificate of Conversion.

1. The name of the converting limited liability company is Liberty Oilfield Services LLC. The Company was initially formed as a limited liability company under the laws of Delaware on August 22, 2011. The file number issued to the Company by the Secretary of State of the State of Delaware is 4985181. The file number issued to the Company by the Secretary of State of the State of Texas as a foreign limited liability company qualified to do business in the State of Texas is 0802435070.

2. Pursuant to the applicable provisions of the Texas Business Organizations Code and Section 18-216 of the Delaware Limited Liability Company Act, the Company is converting into a Texas limited liability company, whose name is Liberty Oilfield Services LLC (the "**Texas LLC**", and such conversion, the "**Conversion**"). 3. A plan of conversion has been approved and adopted in accordance with the applicable provisions of the Texas Business Organizations Code and the governing documents of the Company.

4. In lieu of providing the plan of conversion, the Company certifies that (i) a signed plan of conversion is on file at the principal place of business of the Company at 950 17th Street, Floor 24, Denver, Colorado, 80202 and (ii) from and after the Conversion, a signed plan of conversion will be on file at the principal place of business of the Texas LLC at 950 17th Street, Floor 24, Denver, Colorado, 80202.

6. A signed copy of the plan of conversion will be furnished on written request without cost by the Company before the Conversion or by the Texas LLC after the Conversion to any owner of the Company or any member of the Texas LLC.

7. In lieu of providing the tax certificate, the Texas LLC, as the converted entity, is liable for the payment of any franchise taxes.

8. This Certificate of Conversion will be effective on December 2, 2021.


