**TERMINATION AND RELEASE OF
GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS**

THIS **TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS** dated as of June 1, 2023 (this “Release”) is made by **UMB BANK, N.A.** (successor-in-interest to Marquette Business Credit, LLC, “Lender”), under that certain Loan Agreement (defined below), in favor of **ATLANCO, LLC**, a Georgia limited liability company (the “Grantor”).

Pursuant to (1) that certain Loan and Security Agreement dated as of June 22, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the “Loan Agreement”) by and between the Grantor and the Lender and (2) that certain Grant of Security Interest in United States Trademarks dated as of June 22, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”) by and between the Grantor and the Lender, and recorded June 23, 2017 in the records of the United States Patent and Trademark Office at Trademark Reel 6090, Frame 0214, the Grantor granted to the Lender a security interest in the Collateral, including all of Grantor’s right, title and interest in and to the Trademarks listed on Schedule I attached hereto. Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Loan Agreement or the Trademark Security Agreement, as applicable.

The Lender now wishes to release and terminate, on behalf of itself and its successors, legal representatives and assigns, the security interest in, and assign any and all right, title and interest in and to, the Collateral, including all of Grantor’s right, title and interest in and to the Trademarks listed on Schedule I attached hereto, under the Loan Agreement or the Trademark Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Lender hereby unconditionally and expressly releases, terminates, discharges and extinguishes, without any reservation, any and all security interests, liens, pledges, charges and other encumbrances of any kind in and to the Collateral, including all of Grantor’s right, title and interest in and to the Trademarks listed on Schedule I attached hereto, granted under the Loan Agreement or the Trademark Security Agreement, and reassigns to Grantor, without recourse, representation or warranty of any kind, all right, title and interest in and to, the Collateral, including all of Grantor’s right, title and interest in and to the Trademarks listed on Schedule I attached hereto.
