## EXECUTION VERSION

RELEASE OF TRADEMARK SECURITY INTEREST, dated as of May 10, 2024 (this “Release”), by CITIBANK, N.A., as Collateral Agent (as defined below), in favor of INDUSTRIAL TECHNOLOGIES AND SERVICES, LLC (formerly known as GARDNER DENVER, INC.), GARDNER DENVER NASH LLC, GARDNER DENVER THOMAS, INC., and THOMAS INDUSTRIES INC. (each a “Grantor” and collectively, the “Grantors”). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement, the Security Agreement or the Trademark Security Agreement (each as defined below), as applicable.

A. Reference is made to (i) the Credit Agreement, dated as of July 30, 2013 (as amended, supplemented or otherwise modified from time to time, the “Credit Agreement”), among the U.S. Borrower, the other Borrowers from time to time party thereto, Ingersoll Rand Inc. (f/k/a Gardner Denver Holdings, Inc.) (“Holdings”), the Lenders from time to time party thereto and Citibank, N.A., as Administrative Agent, Collateral Agent (in such capacity and as successor in interest to UBS AG, Stamford Branch in such capacity, the “Collateral Agent”), Swingline Lender and a Letter of Credit Issuer, (ii) the Security Agreement, dated as of July 30, 2013 (together with all amendments and modifications, if any, from time to time, the “Security Agreement”), among the U.S. Borrower, the Grantors, other grantors from time to time party thereto and the Collateral Agent, and (iii) the Grant of Security Interest in Trademark Rights, dated as of January 7, 2020 (the “Trademark Security Agreement”) made by the Grantors in favor of the Collateral Agent, which security interest was recorded on January 9, 2020 with the United States Patent and Trademark Office (the “USPTO”) at Reel 6834 and Frame 0219.

B. The Trademark Security Agreement was supplemented by that certain Partial Release of Trademark Security Interests, dated April 1, 2021, which was recorded on April 1, 2021 with the USPTO at Reel 7240 and Frame 0840.

C. Pursuant to the Security Agreement and Trademark Security Agreement, each Grantor granted to the Collateral Agent, for the benefit of the Secured Parties to the secure payment, performance and observance of the Obligations, a security interest in all of such Grantor’s right, title and interest in, to and under the Collateral (as defined in the Trademark Security Agreement), including, without limitation, the Trademarks listed on Schedule I hereto, including the right to receive all Proceeds therefrom (collectively, the “Released Trademark Collateral”).

D. In connection with the payment and discharge of all Obligations of the Credit Parties under the Credit Documents and the termination of all Commitments under the Credit Agreement, the U.S. Borrower has requested and the Collateral Agent has agreed to execute and deliver this Release for filing and recordation with the USPTO to evidence the release of its security interest in the Released Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby states as follows:

1. Pursuant to Sections 12.11 and 13.1 of the Credit Agreement and Section 6.5 of the Security Agreement, the Collateral Agent does (i) hereby terminate, release, relinquish, cancel and discharge its security interest in the Released Trademark Collateral, and any

right, title or interest of the Collateral Agent in the Released Trademark Collateral shall hereby cease and become void, and (ii) hereby re-assign, re-transfer and re-convey to the applicable Grantor any and all right, title, and interest that the Collateral Agent may have in, to or under such Released Trademark Collateral, provided, however, that this release is being made without recourse to, or any representation or warranty by, the Collateral Agent. The Collateral Agent hereby terminates and cancels the Trademark Security Agreement.


2. The Collateral Agent hereby agrees, upon reasonable request and at the sole expense of the of the Grantors, to duly execute, acknowledge, procure and deliver such further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby. The Collateral Agent hereby authorizes and requests that the USPTO record this Release.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK.
