NOW, THEREFORE, in exchange for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR hereby confirms that by a prior ASSIGNMENT AND ASSUMPTION AGREEMENT dated and effective as of October 25, 2023, ASSIGNOR assigned and transferred to ASSIGNEE its entire right, title and interest in and to the TRADEMARKS, together with the business and the goodwill of the business associated with the TRADEMARKS. To the extent not already assigned and transferred by the prior agreement, ASSIGNOR hereby sells, assigns and transfers to ASSIGNEE its entire right, title and interest in and to the TRADEMARKS, together with the business and the goodwill of the business associated with the TRADEMARKS; and

ASSIGNOR hereby confirms that by the prior ASSIGNMENT AND ASSUMPTION AGREEMENT dated and effective as of October 25, 2023, ASSIGNOR assigned and transferred to ASSIGNEE all claims for damages by reason of past and current infringement of the TRADEMARKS, and the right to sue for and collect the same. To the extent not already assigned and transferred by the prior agreement, ASSIGNOR does also hereby sell, assign and transfer unto ASSIGNEE all claims for damages by reason of past and current infringement of the TRADEMARKS, and the right to sue for and collect the same; and

ASSIGNOR further authorizes the Commissioner of Patents and Trademarks of the United States and any official of any country foreign to the United States whose duty it is to record the rights to the TRADEMARKS as listed in the annexed Schedule of Trademarks as the property of ASSIGNEE; and

ASSIGNOR further agrees to execute such further documents as may be required to record and/or establish ASSIGNEE as the owner of the TRADEMARKS, and all rights herein assigned.
