## ASSIGNMENT OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Assignment of Intellectual Property Security Agreement (this “Assignment”) is made this 14<sup>th</sup> day of May, 2024, by Silicon Valley Bank, a division of First-Citizens Bank & Trust Company (the “Original Assignee”) in favor of NaHCO3 CI, LLC, a Delaware limited liability company (the “New Assignee”).

WHEREAS, the Original Assignee is party to that certain Intellectual Property Security Agreement, dated as of April 26, 2018 (the “Intellectual Property Security Agreement”), pursuant to which Outdoor Voices Inc., a Delaware corporation (the “Grantor”) granted to the Original Assignee a security interest in certain trademarks, including, without limitation, trademarks identified in **Schedule A** (collectively, the “Trademark Collateral”); and

WHEREAS, the Intellectual Property Security Agreement was recorded at the United States Patent and Trademark Office on April 27, 2018 at Reel and Frame No. 6356/0894, pursuant to which each Grantor confirmed the grant to the Original Assignee of a security interest in the Trademark Collateral; and

WHEREAS, the Original Assignee and the New Assignee are parties to that certain Non-Recourse Loan Document Sale and Assignment Agreement, dated as of October 23, 2023, by and among the New Assignee and the Original Assignee (the “Non-Recourse Loan Document Sale and Assignment Agreement”) pursuant to which the Original Assignee has sold, assigned and transferred to the New Assignee all of the Original Assignee’s right, title and interest in, to and under the existing loan documents and related security interest in the Trademark Collateral among the Grantor and the Original Assignee, and the New Assignee accepted and assumed all of the Original Assignee’s right, title and interest in, to and under the existing loan documents and related security interest in the Trademark Collateral among the Original Assignee and the Grantor.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, this Assignment will confirm that the Original Assignee has sold, assigned and transferred to the New Assignee, its successors or assigns, without representation or warranty by or recourse to the Original Assignee except as expressly set forth in the Non-Recourse Loan Document Sale and Assignment Agreement, all right, title and interest of the Original Assignee in and to the Intellectual Property Security Agreement and all rights, privileges and obligations thereunder.
