INTELLECTUAL PROPERTY SECURITY AGREEMENT TERMINATION

WHEREAS, **ZEROFOX, INC.**, a Delaware corporation located at 1834 S. Charles St., Baltimore, MD 21230 (the “Grantor”), and Stifel Bank, a Missouri state chartered bank, located at 787 Seventh Avenue, 11th Floor, New York, New York 10019 and/or 8000 Maryland Avenue, Suite 100, Clayton, MI 63105 (the “Secured Party”), entered into a certain Intellectual Property Security Agreement, dated as of January 7, 2021 which was recorded in the United States Patent and Trademark Office (i) on February 2, 2021 at Reel 7177 and Frame 0865 for trademarks and (ii) on January 28, 2021 at Reel 055066 and Frame 0916 for patents (together, the “First Agreement”), and the Intellectual Property Security Agreement, dated as of June 7, 2023 which was recorded in the United States Patent and Trademark Office on June 16, 2023 at Reel 063976 and Frame 0113 for patents (the “Second Agreement”) (together, the “Agreements”) and that by its terms granted Secured Party a security interest in certain intellectual property including intellectual property listed in Exhibits A, B, and C to this agreement; and

WHEREAS, the Grantor has caused to be paid and satisfied in full the obligations for which the security interest in the Agreements was granted.

NOW THEREFORE the Secured Party hereby releases all security interests granted in the Agreements, including without limitation all right, title, and interest in, to, and under Grantor’s intellectual property collateral, including but not limited to all proceeds thereof, the right to sue for past, present, and future infringements, all rights corresponding thereto throughout the world, and all re-issues, divisions, continuations, renewals, extensions, and continuations-in-part thereof, and in Exhibits A, B and C attached hereto. The Secured Party further agrees, for itself, its successors and assigns, to execute such further documents and to perform such further lawful acts as may reasonably be requested by the Grantor, to effectuate this termination.

IN WITNESS WHEREOF the Secured Party hereto by the signature below of its duly authorized representatives agrees to be bound by the provisions of this Intellectual Property Security Agreement Termination as of the date of execution, this 13th day of May, 2024.


