**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (“Release”) is made as of May 23, 2024, by SILICON VALLEY BANK, A DIVISION OF FIRST-CITIZENS BANK & TRUST COMPANY, a North Carolina state chartered bank (“Lender”), in favor of JUNO LIVE INC., a Delaware corporation (“Grantor”).

WHEREAS, Grantor entered into a certain Intellectual Property Security Agreement, dated as of September 19, 2022, with Lender, notice of which was recorded with the United States Patent and Trademark Office on September 22, 2022 at reel/frame 7857/0843 (the “Security Agreement”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.

WHEREAS, Grantor granted to Lender, under the terms of the Security Agreement, a continuing security interest in favor of Lender, in and to all of their right, title and interest in and to the Intellectual Property Collateral (as defined in the Security Agreement), including without limitation the intellectual property listed in Schedule I attached hereto.


WHEREAS, Lender has agreed to terminate and release its security interest in all such Intellectual Property Collateral as herein provided.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Lender hereby (a) releases, terminates and discharges its security interest in the Intellectual Property Collateral, including the intellectual property listed on Schedule I attached hereto and made a part hereof, (b) terminates the Security Agreement and (c) assigns, transfers and conveys to Grantor any right, title or interest, including the security interest, it may have in the Intellectual Property Collateral of Grantor. Grantor, or any successor to Grantor (including any person or entity hereafter having any right, title or interest in or to the Intellectual Property Collateral of Grantor), is hereby authorized to record this Release in the United States Patent and Trademark Office.
